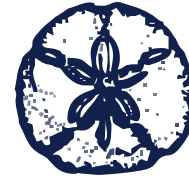

**Important Information-Please Reply**

The Federal Communication Commission published its final rule changes on unsolicited faxes under the Telephone Consumer Protection Act of 1991.

The new FCC rules, effective January 1<sup>st</sup>, 2005, prohibit any person or entity including non-profit, tax-exempt associations, from sending an unsolicited advertisement to a fax machine. The only exception is where the recipient has signed a written consent form that clearly indicates the recipient's consent to receive facsimile ads from the sender.

**Update**

As of January 1<sup>st</sup>, 2005 the new rules requiring written consent before sending advertising faxes took effect. We need this information for our records, as we will be e-mailing and faxing newsletters, luncheon notices, etc. in the future.
